

**TOWN OF DELHI
BOARD MEETING**

April 11, 2011

The meeting was called to order at 7:30 pm by Deputy Supervisor Michele DeFreece.

Those present: Council members, Allan Reed, James Bracci and Kevin Lee; Town residents Barbara Moore, Joan Townsend, Matt Moyse, Kim Cairns; Reporter Robert Cairns.

Pledge of Allegiance was led by James Bracci

Approval of March 14, 2011 Board Meeting minutes – A motion was made by James Bracci and seconded by Allan Reed to accept the minutes. Motion carried.

Privilege of the Floor – Charles Eustis discussed the old cemeteries in Delhi. He said a lot of them are in very bad condition and are in need of attention. NYS mandates that town's maintain cemeteries. The one he is most concerned about is the Foote Cemetery on Arbor Hill. A lot of Delhi's founding fathers are buried there and it contains a lot of our town's history. Allan Reed will work through the cemetery with Charles Eustis and do an evaluation.

John Esposito informed the Board that Delhi Telephone will no longer sponsor broadcasting of the Town board meetings. O'Connor Hospital is the new sponsor so the taping of our meeting can now be seen on Time Warner Channel 23. John will provide the Town Clerk with a copy of the video of the meeting so it can also be shown on our webpage.
