APPOINTMENT OF W. ALLAN PERKINS AS DEPUTY SUPERVISOR

<u>AUTHORIZATION FOR TOWN BOARD REPRESENTATIVE TO RECREATION</u> COMMITTEE TO SPEND FUNDS LESS THAN \$2,500

Motion that the Recreation Committee with the approval of the Town Board representative is hereby authorized to spend amounts not to exceed the sum of \$2,500 without first approval of the Supervisor or Deputy Supervisor was made by Rod Decker seconded by Al Perkins and carried.
